II.	1 st floor BMW Collection Area behind matron office.	<ul style="list-style-type: none">• Syringe and needle cap in blue dustbin.
III.	Gynae Ward BMW Collection Area.	<ul style="list-style-type: none">• Cotton was found in red poly bag.• NS Bottles were found in black poly bag.
IV.	Ultrasound Galleries	<ul style="list-style-type: none">• Mismatch colored poly bag. (Yellow colored poly bag installed was in black dustbin.)
V.	Emergency Ward	<ul style="list-style-type: none">• Needles recapping were found in puncture proof container.
VI.	OT-1 st Floor pre-operative Room	<ul style="list-style-type: none">• Needles recapping was found in puncture proof container
