ORDER

Sub: Starting/increase of seats in various Postgraduate courses for the academic session 2014-15 at Shri Ram Murti Smarak Institute of Medical Sciences, Bareilly, Uttar Pradesh -Permission of Central Govt.- regarding.

Whereas, the institute Shri Ram Murti Smarak Institute of Medical Sciences, Bareilly, Uttar Pradesh was issued conditional permission by the Ministry to start the below noted courses vide this Ministry's letter dated 15.04.2014 subject to submission of relevant compliance and Bank Guarantee of required amount to the Ministry before 30th April 2014:-

2. Whereas, the college brought to the notice of the Ministry that it submitted the requisite Bank Guarantees bearing No. 52240000314, 52240000414, 52240000514 and 52240000214 dated 15.04.2014 issued by Oriental Bank of Commerce, Bareilly on 21.04.2014 i.e. before the stipulated date of 30.04.2014 but the conditions have not been revoked or final permission has been granted by the Ministry.

3. Whereas, the MCI vide letters dated 8.8.2014 and 22.12.2016 confirmed that the original Bank Guarantees issued by the Oriental Bank of Commerce, Bareilly as received from the Ministry of Health and Family Welfare are lying with the MCI.

4. Now, therefore, the Ministry orders that the conditions in Ministry's conditional permission letter dated 15.4.2014 for the above noted courses at Shri Ram Murti Smarak Institute of Medical Sciences, Bareilly, Uttar Pradesh stand revoked at the relevant time. The permission accruing on account of revocation of conditions shall be for such time the first batch of students admitted against the above courses appear for final examination in the subject. The college authorities shall take up the matter for recognition of the qualification (s) under Section 11(2) of IMC Act at the time of first batch admitted against the course appears for final year examinations. The Government of India reserves the right to withdraw/cancel/revoke the Letter of Permission if it comes to the notice that the permission has been obtained by misinterpretation of facts or fraud. The college authorities are bound to intimate material change, if any, in the facts based on which the permission was sought/obtained.
