I am directed to state that the Board of Governors at its meeting held on 20.12.2018 considered the Assessment Report (28th May 2018) on the standard of examination and other teaching facilities available at Shri Ram Murti Smarak Instt. of Medical Sciences, Bareilly, Uttar Pradesh for purpose of Recognition of MS(General Surgery) qualification against increased intake from 2 to 4 seats granted by MJP Rohilkhand University and decided as under: -

"The Board of Governors considered the Assessment Report (28th May 2018) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that MS(General Surgery) qualification against increased intake from 2 to 4 seats granted by MJP Rohilkhand University in respect of students being trained at Shri Ram Murti Smarak Instt. of Medical Sciences, Bareilly, Uttar Pradesh be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

Note: The above recommendations are subject to Blood Bank license."
