AIM AND PURPOSE

DATE AND VENUE

Moot Court Competition 2020 shall be held from 21st -22nd February 2020 at Moot Court Room SRMS College of Law.

ELIGIBILITY

The competition is open for all the students of 3 year LL.B. and 5 year B.A. LL.B/BB.A. LL.B/B.COM LL.B. course of all semesters conducted by any recognized College / Institution/ University.

GENERAL RULES

- **Language:**
The official working language of the Moot Court Competition shall be English.
- **Dress Code:**
During all the Days of the competition, the participants shall be in Formal wear only.
 - i) Male participants are required to wear a Full Formal Suit i.e. Black Trousers, White Shirt, Black Tie, Black Coat, and Black Formal Shoes.
 - ii) Female participants are required to wear a Full Formal Suit i.e. Black Trousers, White Shirt, Black Coat and Black Formal Shoes or Indian Formal Dress i.e. White Saree / Salwar Suit Along With Black Coat And Black Bellies.
- **Team Composition:**
 - i. Each team shall consist of 3 members. This number cannot be modified under any circumstances. Two of them shall be designated as a Speakers and one researcher.
 - ii. Teams shall identify the speakers and researchers during registration. No extra member or observer shall be allowed.

- iii. Any additional member of any Participating Team shall not be entitled to hospitality or for any award. Such member or observer shall not be allowed to watch any of the rounds of the competition.
- iv. Each team will have a Team Code.
- v. Teams shall not disclose their identity except in the registration form. Any such disclosure shall invite strict penalty including disqualification. The decision for the same shall be at the discretion of the Organizers.
