#### **ABOUT THE COLLEGE**

#### **PURPOSE OF THE COMPETITION**

The purpose of this activity is to give exposure to students pursuing the Integrated B.A. LL.B & LL.B course to hone their advocacy skills and to provide a real litigation experience in doing cutting edge research, presenting persuasive and cohesive argument and contributing to the development of jurisprudence in concerned areas of law.

Client counselling is one of the most important parts of legal profession. It involves both the interviewing and advising abilities of an advocate. No doubt Advocates have both the good listening and questioning abilities as a part of advocacy skills. However, it is not easy for a new advocate who has just completed law and enrolled as an advocate. Being in academia it is our pious duty to teach them about this important aspect of legal profession. Therefore, an initiative has been taken by SRMS COLLEGE OF LAW to organise a client counselling competition. So that students must develop a greater ability to understand legal aspects and develop a spirit of enquiry into legal matters. This Competition as expected encourages students of law to inculcate interviewing, planning and analytical skills. The most vital part of this competition is to make the students aware about"How to build and maintain good relationship between advocates & clients?"

#### DATE AND VENUE

Client Counselling Competition 2022 shall be held on 27th August, 2022 from 9:00 AM to 5:00 PM at SRMS College of Law, Bareilly.

#### **ELIGIBILITY**

The competition is open for all the students of 3 year LL.B and 5 year B.A. LL.B/BB.A. LL.B/B.COM LL.B. course of all semesters conducted by any recognized College / Institution / University.

#### **Registration:**

#### **GENERAL RULES**

This Competition involves the following registration process: Note:

- By registering for and/or entering this Competition, all participants agree to be bound by the rules contained herein. a.
- By entering this Competition, all participants consent to being photographed or filmed and to such images photographed b. and/or videos filmed being published by SRMS, College of Law, Bareilly, U.P.
- Participating teams must register themselves for the Competition by submitting online a pro-forma of registration, before с. the stipulated deadline for such submission.

Note: Registration fees of ₹500/- is to be deposited on spot dated: 27/08/2022

Official Language: The official language of the Competition shall be English. All written and/or oral submission made to and/or before the judges shall be in English.

#### **Rules of the Competition:**

#### Rule 1. Entry into the Competition:

- (a) Composition of the Teams: Each team shall consist of the two students (only).
- Eligibility: Law students from recognised Universities. Only two team per institute can participate. In case more than two (b) entries are received from the same institute, the first two teams registering will be allowed to participate.
- Team Codes: After successful registration, each participating team will receive a unique team code from the organiser. (c)
- NOC: It is mandatory for each participant comprising a team to get the No Objection Certificate signed by the Dean/ (d) Head of the institute. Any entry without the NOC shall be rejected immediately.

#### Rule 2: The Consultation Situation, Theme of the Competition, Applicable Laws.

- **Distribution of the Consultation Problem:** The participating teams will not receive the consultation problem before the (a) competition. The problem shall be made available to the Client who shall then further present the information before the participating team in her/his own words. Based on the information so presented, the team members will decide their counselling strategy and client dealing. However, approximately 7 days before the competition, the organisers will send to each team a brief description relating to the consultation problem. This will contain information similar to that which a law office secretary might record when informing lawyers of a forthcoming appointment.
- **The Theme of the Competition:** The consultation problems will be related to family law. (b)

#### **Rule 3: Rounds**

The competition shall consist of four rounds consisting of Preliminary, guarter final, Semi Final and Final. To gualify for the final round a participating team must qualify semi-final rounds.

#### Rule 4. The Consultation and Post Consultation Session

#### Rounds: This competition shall consists of the following the rounds-

The students are required to be dressed in black and white formal attire typical of a lawyer. **Clients:** The individuals plying clients will be selected and briefed by the organisers. Time limit for the Session: Each team shall have a maximum of 25 minutes to complete the session. This includes 20 minutes for the consultation and 5 minutes for the post consultation session. Any team exceeding the prescribed time

The consultation Session: Each team must conduct a consultation with the client during which the students are excepted to elicit the relevant information, outline the problem, and propose options for resolving the problem. The discussion of the fees is an integral part of any first consultation between a lawyer and a client. Students should be judged as how they approach this problem, but not on the monetary amount used. The participants may discuss fees at any appropriate point in the consultation. Fees may be waived or suitably reduced only in cases of financial hardships, either for persons

The Post Consultation Session: Each team must also conduct a meaningful post- consultation discussion between the attorneys after the client has left the rooms. The post consultation session the participating teams are expected to summarise the interview, indicate the next steps to be undertaken, and state the legal issues that should be researched.

The Competition shall comprise of two preliminary rounds following which, two teams from each group shall qualify for

Four teams with the highest absolute score in the guarter-final rounds shall gualify to the semi-final rounds.

Two teams with the highest absolute score shall qualify from the semi-final rounds to the final round.
